GUIDELINES FOR MANUSCRIPTS

I. GENERAL GUIDELINES

- The name of the file sent to the journal must contain the authors' surname in English (e.g. Petrov Ivanov).
- The article must be at least 25 thousand characters (including footnotes, spaces and bibliography) and shouldn't exceed 40 thousand characters (including footnotes, spaces and bibliography).
- The article must have a clear structure: Introduction (which describes the relevance and novelty of the topic, the aim and goals of the research); the main part (which is divided into several parts and describes methodology and results) and Conclusion (must contain the main inferences and further possible ways of the research). The article can't be written as a text without parts.
- If the article doesn't correspond to the guidelines, the board of editors can decline it.

II. PREPARING THE MANUSCRIPT

- Text editor Microsoft Word (.doc or .docx).
- Format A 4.
- Margins the top and bottom margins should be 2 cm, the left margin 3 cm, the right margin 2 cm.
- Font Times New Roman.
- **Font size** 12 pt.

- Line spacing 1.5.
- Paragraph indentation 1.25.
- The surname and name of the author(s) are highlighted in italics, bold, on the right edge, size 12 pt.
- The title of the article centered, highlighted in bold, size 12 pt.
- The author affiliation must contain:
 - the surname, the name,
 scientific degree,
 academic title,
 the name of an organization,
 city,
 country,

- The Abstract in Russian (font size 10 pt) should be informative, original, relevant and concise (100–200 words), follow the structure of the paper and contain the following parts: relevance of the research, methods, results and conclusion.
- **Keywords** provide at least 5 keywords.
- The text of the article width alignment.
- Figures and Tables. The language of the tables and figures must be the same as the language of the article. The table must have the caption above it and the figure below it. The footnote must contain the source of information used in the table or figure.
- The surname, the name, the article title, information about the author(s), e-mail, Abstract and Keywords in English must be given after the bibliography.

III. REFERENCES IN THE TEXT

• References to scientific papers are designed as **intra-text**, **page-by-page bibliographic references** compiled in accordance with the requirements of GOST 7.0.5-2008.

• Monography:

- 1. Surname and name of the author(s),
- 2. The title of the book,
- 3. Editor/translator,
- 4. Place of publishing,
- 5. Publisher,
- 6. Year of publishing.

- 1. Surname and name of the author(s),
- 2. The title of the article,
- 3. The name of the journal,
- 4. Place of publishing (for all works except for articles in the journals),
- 5. Year of publishing,
- 6. Issue/Volume,
- 7. Pages or Internet source (URL and access date),
- 8. DOI.

• References to newspapers, Internet sources, laws and archive data must be provided as footnotes, and these works are not necessary to be put in the Bibliography: Election results 2019: Which party got the most votes... and other questions // BBC [Internet source]. URL: https://www.bbc.com/news/election-2019-50779901 (accessed: 21.01.2020). Archive data: Центральный архив города Москвы (ЦАГМ). Ф. 1609. Оп. 1. Ед. хр. 529.

IV. BIBLIOGRAPHY (СПИСОК ЛИТЕРАТУРЫ)

- Bibliography includes **scientific works**, **articles in scientific journals**, i.e. it contains all works which are used in the article and given in the footnotes.
- Bibliography must be **alphabetically arranged according to ΓOCT 7.0.5-2008**. Works in Russian should be placed first, then works in other languages.
- Bibliography must contain at least 15 scientific works. Scientific works are articles in
 the scientific journals, monographies, etc. Sources are legal acts, media, statistical and
 analytical reports, etc. Using textbooks, handbooks, dictionaries, PhD thesis should
 be minimized.
- At least 50% of works in the bibliography must be written in last 5 years.
- If a **massive reviewing** of works that are relevant for the manuscript is necessary, it should be given in a **special part** (Literature Review).
- A massive self-citation is not allowed.




Figure 1. Spread of the new China virus¹
